Review of 2011-12 State Meets Bob/Mike

Mike commented that the schedule went well.

2A coaches stated that their meet seemed to have too much time between events.

The competition was high caliber and exciting.

Chris Erickson asked to see if it has been considered for the proportions of 2A, 3A, 4A schools that need to travel far distances to attend the meet. Should this be considered for the rotating timeline each year? Bob Regan said that WIAA feels that the revolving state meet timeline (morning, afternoon, evening sessions) should be kept as a way to things fair for all teams. Consensus is that the current schedule is great and those present enjoy the timeline as is.

2A Don Helling mentioned the district diving scoring is not consistent.

Work on some black and white standards of diving performances so it is not so subjective with scoring.

Athletes can earn inflated scores that qualify for State but are not accurate measures of their diving ability.

What is the effect for raising the Degree of Difficulty to assure state diving qualifiers are authentically state level divers? Coy Jones can be contacted about this possibility.

WISCA Recommendations for Criteria of Accepted State Qualifying Times

We need to consider creating a written criteria for acceptance of State qualifying times.

Swimming is only sport that has state qualifying times throughout the season.

How can we better assure that swim meet results that are posted on the WISCA site are accurate and legitimate?

Should alumni meets with state qualification times that do not have the normative schedule of high school meets count as legitimate?

Alumni meets are accepted and approved as a meet and count as 1 of the maximum of 12 meets; however State times from these meets are not

accepted.

Incomplete meet results without opponents identified or without proper officials with the signatures of officials are not accepted.

Coaches should identify the name of the officials/referee within the email when they submit the meet results.

All pools must have objective meet officials who can certify a meet (not coaches).

Following the National Federation meet expectations is benchmark for all Washington high school swim meets.

Coaches must setup the required meet officials to be sure that results from meets are able to be certified.

Carlos proposed the idea of creating a master list of officials who can be called upon to officiate a meet.

The importance of turning in all meet results to the WISCA site was emphasized; a handful of coaches are failing to meet this clearly stated protocol identified in the fall WISCA minutes and posted on the WISCA site for all to notice and comply with; there are no excuses. Coaches who are not following this protocol may be reported to WIAA and their Athletic Directors may be notified of the necessity to report meet results.

All meets and especially those with state times are required to be posted to the WISCA site.

Do not hide your swimmers.

WISCA Board member Don Helling will draft a proposed short explanation for the Board to review that clarifies these expectations for the WISCA site and be given to all WA coaches.
